

INTERIM EDICTS
PASSED BY THE FIRST SUPREME COUNCIL
OF PHI GAMMA NU SORORITY

July 18, 1929

INTERIM EDICT I.

Every member of this sorority shall be registered with the Grand Treasurer. The Number placed on the membership certificate will register both member and pin.

INTERIM EDICT II.

Founders' Day Services shall be held each year in local chapters on February 17, at which time the Grand President's message will be read, followed by the reading of the oath to PHI GAMMA NU SORORITY and the reading of the purposes of this organization.

INTERIM EDICT III.

A minute book with ledger sheets giving the following information:

Date of meeting,
Regular or special meeting,
number attending,
Number which were excused,
Total number of Chapter.

This shall be kept by the secretary of each chapter. The size of the minute book shall be 8 1/2 x 11.

INTERIM EDICT IV.

All pledges must wear either white dresses or evening dresses at initiation, depending upon the choice of the local chapter.

INTERIM EDICT V.

A scholarship key to be known as THE PHI GAMMA NU SORORITY SCHOLARSHIP KEY shall be presented to the woman student having the highest general average and who is a major in commerce, upon the completion of the degree or certificate requirements.

INTERIM EDICT VI.

All pins must be ordered either through the Grand President or the Grand Treasurer.

The cost of the full pearl pin shall be eighteen (\$18.00) dollars without the guard and the cost of the half pearl shall be ten dollars (\$10.00) without the guard. The pin with half pearl guard shall be twenty (\$20.00) dollars and with whole pearl twenty-two (\$22.00) dollars. The half pearl pin with full pearl guard shall be Fourteen (\$14.00) dollars and with the half pearl guard twelve (\$12.00) dollars.

The pledge pins shall be one (\$1.00) dollar each and the crest for the past presidents shall be two and a half (\$2.50) dollars.

INTERIM EDICTS
PASSED BY THE FIRST SUPREME COUNCIL
OF PHI GAMMA NU SORORITY

INTERIM EDICT VII.

Before a local chapter of Phi Gamma Nu Sorority may sign a lease of property, whether a house or apartment, buy any real estate or enter into a contract for the building of a house, a written statement of approval by the dean of the college where the chapter is located, a written statement of approval by the local alumnae chapter, and a statement as to the method of financing the proposition, must be sent to the Grand President and to the Grand Treasurer for their files.

INTERIM EDICT VIII.

This interim edict is to supersede interim edict VI, which was passed by the Supreme Council on July 18, 1929.

All orders for sorority jewelry must be sent to the Grand Treasurer on the form prescribed by the Grand Treasurer, a check for the full amount accompanying the order. The Grand Treasurer will not place orders for jewelry if such a check is not received.

The cost of the full pearl pin shall be eighteen dollars (\$18.00) without the guard and the cost of the half pearl shall be ten dollars (\$10.00) without the guard. The pin with half pearl guard shall be twenty dollars (\$20.00) and with whole pearl guard shall be twenty-two dollars (\$22.00). The half pearl pin with full pearl guard shall be fourteen dollars (\$14.00) and with the half pearl guard twelve (\$12.00) dollars.

All silver crests shall cost seventy-five cents (75¢) and shall be placed on jewelry or favors; all gold crests used in such manner shall be one dollar and fifty cents (\$1.50). The price of the scholarship key shall be seven dollars (\$7.00) exclusive of engraving.

INTERIM EDICT IX.

All national dues and assessments must be received by the Grand Treasurer within ten days following the time indicated for their payment in Article IX of the By-Laws of Phi Gamma Nu Sorority. A fine of fifty cents for every day elapsing beyond this time limit must be paid to the Grand Treasurer.

INTERIM EDICT X.

The National magazine of Phi Gamma Nu Sorority shall be mailed by the Editor to all members paying Grand Chapter dues, the list to be submitted by the Grand Treasurer in accordance with her records on October thirtieth and March thirtieth of each year.

INTERIM EDICT XI.

Members of the sorority eligible for membership in the Alumnae Association and living in a locality where there is such a chapter shall be considered in bad standing unless they pay alumnae dues.

INTERIM EDICT XII.

The Grand Treasurer shall be bonded for an amount set by the Supreme Council. She shall pay all bills pertaining to sorority business after such bills have been approved by two grand officers. The checks for this Sorority shall be signed by the Grand Treasurer, no counter signature being necessary.

INTERIM EDICTS PASSED
BY THE SECOND SUPREME COUNCIL
OF PHI GAMMA NU SORORITY
JUNE 1931

INTERIM EDICT NO. 1.

The holder of the office of ADVISOR must be appointed by a majority vote of the Active Chapter, in accordance with our Constitution and By-Laws.

INTERIM EDICT NO. 2.

Interim Edict No. 3 of the First Supreme Council was accepted and the Grand Vice President of the Second Supreme Council shall purchase eight (8) banners.

INTERIM EDICT NO. 3.

Each Active Chapter shall be required to read the Constitution and By-Laws within each school year and pass an examination once a year over it-this examination shall be under the supervision of the Grand President.

INTERIM EDICT NO. 4.

The Phi Gamma Nu Sorority shall adopt the procedure of presenting the President's Crest to the President at the time of the Founder's Day Ceremony.

INTERIM EDICT NO. 5.

The original badge for Supreme Council Members shall be changed as follows:- The stones on the main badge in the Gamma shall be revised - a pearl where the Ruby is and Rubies where the Pearls are. The Grand President to receive such a pin except a diamond where the Ruby is in the original badge or the Pearl in the Supreme Council Badge.

INTERIM EDICT NO. 6.

The Grand President shall send out to officer of Active and Alumnae Chapters letters instructing them relative to their conduct toward the Supreme Council, Members, Honorary Members and Honorary Founders.

INTERIM EDICT NO. 7.

The Grand Secretary and Grand Editor are to be allowed thirty five dollars (\$35.00) each for the purchase of typewriters. The typewriters to remain the property of the Supreme Council of Phi Gamma Nu Sorority.

INTERIM EDICT NO. 8.

The Grand Chapter Treasury shall pay expenses incurred by newly-elected national officers, such as additional hotel bills and meals, which are caused by their election at the time of the Grand Chapter Congress.

INTERIM EDICT NO. 12.

The provisions in the National By-Laws of Phi Gamma Nu Sorority as stated in Article IX, Section 1 shall be set aside for the academic year 1932-1933 insofar, only, as the amounts of initiation fee and national dues are concerned. All other parts of the Article IX Section 1, shall remain in force, but the following schedule of fees shall replace the schedule given in this section:

Initiation fee, 1932-1933	\$6.00
First semester dues, 1932-1933	\$2.00
Second semester dues, 1932-1933	\$1.00
and	

For those persons active only during the second semester of 1932-1933 the second semester dues shall be . . . \$1.50

In like manner all parts of Article IX, Section 4, of the National By-Laws of Phi Gamma Nu Sorority shall remain in effect, with the exception of the amount of national dues to be paid by each alumnae member, and that amount shall be reduced to \$1.50 for 1933-1934. Those alumnae members who have already paid \$2.00 in national dues 1932-1933 shall receive a credit of 50¢ on their dues for 1933-1934, but will not be considered as being in good standing until they have completed such payment of national dues. It shall be the responsibility of the local alumnae treasurer to see that such credits are properly given by the Grand Treasurer.

INTERIM EDICT NO. 13.

The provisions in the National By-Laws of Phi Gamma Nu Sorority as stated in Article IX, Section 1, shall be set aside for the academic year 1933-34 insofar, only, as the amounts of initiation fee and national dues are concerned. All other parts of the Article IX, Section 1, shall remain in force, but the following schedule of fees shall replace that schedule given in this section:

Initiation Fee, 1933-34	\$6.00
First Semester Dues, 1933-34	2.00
Second Semester Dues, 1933-34	1.00
and	

For those persons active only during the second semester of 1933-34 the second semester dues shall be \$1.50

In like manner all parts of Article IX, Section 4, of the National By-Laws of Phi Gamma Nu Sorority shall remain in effect, with the exception of the amount of national dues to be paid by each alumnae member, and that amount shall be reduced to \$1.50 for 1933-34.

INTERIM EDICT NO. 14.

Life Membership

Article 9, Section 5. "The life membership fee shall be \$10.00, payable to the Grand Treasurer, by any alumna in good standing. The member shall thereby be excused from paying any national alumnae dues for the rest of her natural life. She shall be considered an alumna member."

INTERIM EDICT NO. 15.

Article X, Section 5. "INSTALLATION FEES FOR ACTIVE CHAPTERS. The charter fee required from each active chapter shall be forty dollars, payable on or before the date of installation unless otherwise provided by the Supreme Council. In addition to this installation fee each chapter shall pay the usual initiation fee required from all members."

Proposed Changes By Delta and Iowa City Alumnae
in Constitution and By-Laws of Phi Gamma Nu Sorority

ARTICLE II

Objects

Section 1. Objects. The objects of this Sorority shall be: to develop friendships among women students of commerce and business administration; to promote a standard of high scholarship; to encourage participation in school activities; to uphold the interests of our Alma Maters; and to further interest in civic and professional enterprises.

ARTICLE IV

Government and Organization.

Section 2. Incorporation. This Sorority shall be known legally as "Phi Gamma Nu Sorority", incorporated February 17, 1927 under the laws of the State of Illinois, as a corporation not for pecuniary profit. Each Active and Alumnae Chapter shall incorporate under the laws of the state in which it is located.

Section 5. The Grand Chapter Congress. The Grand Chapter Congress shall be the supreme power of this sorority and shall be composed of one representative from each Active and each Alumnae Chapter in good standing. Each Active or Alumnae Chapter may send as many delegates to a meeting of the Grand Chapter Congress as it may desire, but only one delegate shall have the right to vote. Grand Office shall not have the power to vote and may not be official delegates from Alumnae Chapters.

Section 6. The Supreme Council. The Supreme Council shall consist of the Grand President, Grand First Vice-President, Grand Second Vice-President, Grand Secretary, and Grand Treasurer. The Supreme Council shall be the supreme executive and legislative body of this Sorority during the interval between the meetings of the Grand Chapter Congress.

ARTICLE V.

Grand Chapter and Grand Chapter Congress.

Section 1. Meetings. The Grand Chapter Congress shall meet triennially during the month of June, at a place selected at the preceding Grand Chapter Congress.

Section 2. Transaction of Business. The Grand President shall preside at the Grand Chapter Congress and the Grand Secretary shall serve as the secretary of the Congress. There shall be no voting by proxy and only official delegates shall have the right to introduce or second motions or make nominations. The Grand Chapter Congress shall elect a Grand President, Grand First Vice-President, Grand Second Vice-President, Grand Secretary, Grand Treasurer, and Grand Editor.

Section 3. Expenses of Official Delegates. The expenses of official delegates of active chapters and of Grand Officers shall be paid from the National Treasury. The expenses of the official delegate from an alumnae chapter shall be paid by the alumnae chapter which she represents or by herself.

ARTICLE VI.

Grand Officers.

Section 1. Election and Tenure. Grand Officers shall be elected by a two-thirds vote of the Grand Chapter Congress. They shall take office upon the adjournment of the Grand Chapter Congress and their tenure of office shall be three years.

Section 2. Grand President. The Grand President shall be the chief executive officer of this Sorority. She shall be the presiding officer at all meetings of the Grand Chapter Congress and of the Supreme Council. She shall have the power to appoint standing committees and any other committees advisable to carry out the work of this Sorority. It shall be her duty to see that all Grand Officers discharge their duties. She shall have further powers and duties as may be prescribed by the laws of this Sorority.

Section 3. Grand First Vice-President. The Grand First Vice-President shall assume all the powers and duties of the Grand President should the office of Grand President be vacated by death or resignation. She shall be responsible for the expansion policy and supervise the organization of all new chapter of Phi Gamma Nu Sorority and receive petitions for charters from these groups. She shall have further powers and duties as may be prescribed by the laws of this Sorority.

Section 4. Grand Second Vice-President. The Grand Second Vice-

President shall be the national visiting delegate and be responsible for the inspection of active and alumnae chapters. She shall supervise the operation of the standard accounting system for active chapters and shall demand at least one financial report each year from each active and alumnae chapter. She shall receive all appeals from disciplinary action of members of chapters. She shall investigate all such appeals and present them together with her suggestions to the Supreme Council. She shall preside as judicial officer at any trial on appeal of a verdict. She shall receive all suggestions for improvement in the insignia and ritual of this Sorority. She shall have further powers and duties as may be prescribed by the laws of this Sorority.

Section 5. Grand Secretary. It shall be the duty of the Grand Secretary to keep all official minutes of the Grand Chapter Congress, of the meetings of the Supreme Council. She shall keep complete records of the membership of this Sorority and shall submit to the Supreme Council all proposed changes in the laws of this Sorority. She shall have further powers and duties as may be prescribed by the laws of this Sorority. The word "and" should be in the second line--- "and of the meetings of the Supreme Council."

Section 7. Grand Editor. The Grand Editor shall edit the Magazine of Phi Gamma Nu and be responsible for the printing and distribution of this publication to all members who have paid their current dues. She shall act as Historian for Phi Gamma Nu Sorority. She may appoint assistant editors with the approval of the Grand President. She is not a member of the Supreme Council.

ARTICLE VII. Membership.

Section 5. Honorary Members. Honorary members shall be those members who have been duly elected by an active chapter and have been approved by the Grand Second Vice-President, but who, at the time of initiation, are not eligible for membership in the above mentioned classes. This membership, which is granted as an honor and distinction, entitles the holder to continual participation in the Active Chapter.

ARTICLE IX. Finances.

Section 3. Other Taxations. The Grand Chapter Congress shall have the power to levy other taxes, if necessary, for the maintenance and development of this Sorority. The Supreme Council shall have the power to levy taxes if by three-fifths vote of all members of the Supreme Council it is deemed advisable for the maintenance and development of this Sorority.

ARTICLE X. New Chapters and Alumnae Chapters.

Section 1. Requirements. Groups of ten or more women students majoring in commerce in an educational institution of collegiate rank which offers organized courses in commerce and business administration, leading to a diploma or degree therein, shall be eligible to petition for a charter. Notice of petition must be filed with the Grand First Vice-President. She shall present it with her suggestions to the Supreme Council.

Section 2. Vote Required to Accept Petition. A three-fifths vote of the Supreme Council shall be necessary to accept a petition and grant a charter for the establishment of a chapter of this Sorority.

Section 3. The Petition. The petition shall give full information regarding the character of all the applicants and other information that may be required by the Grand First Vice-President.

Section 4. Members Eligible for the Alumnae Chapter of the Petitioning Group. Members eligible for the Alumnae chapter of the petitioning group shall be initiated into membership provided their applications for membership are filed with the Grand First Vice-President and all initiation fees required of an active member are paid and available on the day of installation. Such members who fail to do so may be initiated by the chapter within six months after installation, upon securing approval of the Grand First Vice-President and the payment of all the initiation fees required of an active chapter.

Section 6. Requirements for Alumnae Chapters. Groups of seven or more members may petition the Grand First Vice-President and be granted a charter to establish an Alumnae Chapter. These members must be in good standing and reside in the locality in which the chapter will be established. The petition must be approved by a majority vote of the Supreme Council.

Section 7. Designation of Alumnae Chapters. Alumnae chapters shall be named after the locality in which they are situated.

Section 8. Date of Installation. The date of installation shall be decided by the Grand First Vice-President and approved by the Supreme Council.

ARTICLE XI.

Discipline of Officers and Members.

Section 1. Grand Officers Other Than Grand President. Failure of any Grand Officer to perform the duties of her office shall be reported to the Grand President who shall investigate and who shall have the power to demand the resignation of the officer involved if she has been negligent in the performance of her duties.

Section 2. Grand President. Should the Grand President fail to perform the duties of her office she may be removed from office by the unanimous vote of the remaining members of the Supreme Council.

Section 3. Chapter Officers. Failure of any chapter officer to perform the duties of her office shall be reported to the Grand Second Vice-President who shall have the power to demand the resignation of the officer involved.

Section 4. Members. If a member violates any law of this Sorority or brings disgrace upon this Sorority upon the vote of three-fourths of the members of her Chapter she may be fined, reprimanded, suspended, or expelled.

Section 5. Trial and Appeal. No member may be expelled from this Sorority without first having been granted a trial. In case of conviction, by the chapter, the accused may appeal to the Grand Second Vice-President.

Section 6. Vote Required. In an Active Chapter or Alumnae Chapter a majority vote of the members present at a regular meeting shall be required to fine, reprimand, or suspend any member. In an Active or

Alumnae Chapter a three-fifths vote of all the members of the Supreme Council shall be required to expell a member.

Section 7. Reports of Expulsion. Within twenty-four hours after expulsion of an active or alumnae member by a chapter a report of the same shall be sent to the Grand Second Vice-President and the Grand Secretary. If the member is expelled by the Supreme Council the Grand Secretary shall within twenty-four hours send a report to the Secretary and Treasurer of the chapter of which the accused was a member. The active member or alumnae member expelled shall be notified of the action taken by registered mail to her last known address by the Grand Secretary within five days after her trial. She shall also be notified of her right to file an appeal with the Grand Second Vice-President within sixty days after receiving the notice of her penalty.

ARTICLE XII.

Discipline of Chapters.

Section 1. Offenses and Penalties. Any chapter of this Sorority may be placed upon probation, may be suspended, or may have its charter revoked, for the violation of any of the laws of this Sorority, or for the non-payment of the obligations due the Grand Treasury. A four-fifths vote of the members of the Supreme Council shall be required to pass such penalties.

Section 3. Revival of Dormant Chapter. A chapter whose charter has been revoked or which was suspended may be recognized after presenting a petition to the Grand First Vice-President and being granted a renewal of their charter or a new charter in accordance with the decision of the Supreme Council.

ARTICLE IV.

Section 7. The Grand Editor. The Grand Editor shall be elected at the Grand Chapter Congress.

By-Laws

ARTICLE V.

Grand Chapter Congress.

Section 1. Election of Delegates and Alternates. Change next to last sentence to: "Any active chapter finding it impossible to send an official delegate from its active membership may elect one of its alumnae members to act as its official delegate.

Section 5. Order of Business. The order of business of the Grand Chapter Congress shall be as follows: call to order; roll call; reading of minutes; report of Grand President; report of Grand First Vice-President; report of Grand Second Vice-President; report of Grand Secretary; report of Grand Treasurer; report of Grand Editor; reports of committees; old business; new business; consideration of proposed constitutional and by-law amendments; selection of place for next Grand Chapter Congress; reading of names of deceased active and alumnae members; nomination of Grand Officers; election; adjournment, and administration of the oath of office to the new Supreme Council.

Section 3. Voting. Election shall be by secret ballot. Official delegates to the Grand Chapter Congress shall vote for the Grand President, Grand First Vice-President, Grand Second Vice-President, Grand Secretary, Grand Treasurer, and Grand Editor, in the order named. It shall complete its vote and announce the result before the nominations shall be opened for the following office. It shall be necessary for the nominee to receive two-thirds of the votes cast to be elected.

Section 9. Expenses of Grand Officers. The expenses of the Grand officers to the Grand Chapter Congress shall be paid out of the Grand Treasury.

Section 10. Expenses of Official Delegates. The expenses of official delegates of active chapters and of Grand Officers shall be paid from the National Treasury. The Supreme Council shall have the power to levy a convention tax annually upon the active chapters, the total amount of which over a period of three years will defray convention expenses of all active chapter delegates. The expenses of the official delegate from an alumnae chapter shall be paid by the alumnae chapter which she represents or by herself.

ARTICLE VII.

Membership.

Section 4. Honorary Members. An approval of the Grand Second Vice-President must be secured before invitation to honorary membership is extended.

ARTICLE VIII.

Active and Alumnae Chapter Officers.

Section 7. Any person upon election to the Supreme Council must resign from any office she may hold in her local chapter.

ARTICLE IX.

Finances.

Section 5. Life Membership. The life membership fee shall be ten dollars, payable to the Grand Treasurer by any alumna in good standing. The member shall thereby be excused from paying any national alumnae dues for the rest of her natural life. She shall be considered an alumna member.

ARTICLE X.

New Chapters and Alumnae Chapters.

Section 1. Petition for Charter. Petition for a charter for an Active Chapter shall be made to the Grand First Vice-President and Signed by at least ten persons eligible to membership.

ARTICLE XI.

Discipline of Active and Alumnae Members.

Section 3. Penalties. Change Grand Vice-President to Grand Second Vice-President.

ARTICLE XIII.

Discipline of Grand Officers

Copy Sections 1 and 2 from Article XI. of the Constitution.

ARTICLE XIV.

Reports.

Section 1. Chapter Reports. "Each Chapter shall report to the Grand Second Vice-President---names and addresses of all officers." Omit next sentence but retain last sentence.

ARTICLE XV.

Official Insignia.

Section 1. Official Badge. The official badge shall be obtained by every initiate. It shall be the regulation size pin, and shall be worn by every member in good standing. The small pin, full or half pearls, with or without a guard, shall be the standard badge for honorary members. All badges remain in the ownership of and under the control of this Sorority.

Section 3. Pledge Pin. The pledge pin shall conform with the specifications of the Grand Second Vice-President. Every pledge shall be presented with a pledge pin which must be returned at the time of the initiation into the Sorority.

Section 5. Official Coat-of-Arms. The official coat-of-arms shall conform with the specifications of the Grand Second Vice-President.

Section 6. Official Seal. The official seal of this Sorority shall conform with the specifications of the Grand Second Vice-President.

Recommendations of Grand President

ARTICLE XV.

Standing Committees

Section 1. The Grand President shall appoint three members to each of the following standing committees: Scholarship, Civic Interest, Professional Interest, Activities, Personality. These appointments shall be made upon the recommendation of the alumnae presidents and in time to become effective the September following the election of the national officers at the time of convention. The term of office shall be for three years.

Section 2. The Grand President shall supervise the work of these committees. Note: part of Sec, 1 might be stated as a By-Law.

ARTICLE XVI.

Expansion Committee.

Section 1. The Grand President shall appoint three or five members, one from each section of the country, to work with her on problems of expansion. These persons shall be alumnae in good standing with their Sorority.

ARTICLE XV.

Amendments.

Section 1. Constitution. This Constitution may be amended, altered or suspended by a two-thirds vote of the Grand Chapter Congress.

Section 2. By-Laws and Interim Edicts. The By-Laws and the Interim Edicts of this Sorority may be amended or revoked by a two-thirds vote of the Grand Chapter Congress.

In addition to present Article XV.

Section 1, or by unanimous consent of the Supreme Council, active and alumnae chapters may be suspended between Grand Chapter Congresses.

Section 2, or by two-thirds consent of the Supreme Council, active and alumnae chapters may be suspended between Grand Chapter Congresses.

Proposed Changes by Chicago Alumnae in Constitution and By-Laws of Phi Gamma Nu Sorority.

Constitution

ARTICLE IV.

Section 6. amended to read as follows: The Supreme Council. The Supreme Council shall consist of the Grand President, Grand Vice-President, Grand Secretary, Grand Treasurer, Grand Auditor, and Grand Editor. The Supreme Council shall be the supreme executive and legislative body of this Sorority during the interval between the meetings of the Grand Chapter Congress. All legislative matters shall be discussed in Alumnae Chapter meetings and the Chapters given the power to veto within 30 days, before a final decision is voted by the Supreme Council.

ARTICLE VI.

Section 6. amended to read as follows: Grand Treasurer. The Grand Treasurer shall have custody of all funds of this Sorority and shall pay all bills which are duly authorized to be paid by the majority vote of the Supreme Council or by the Grand President. She shall keep a record of account and publish a Balance Statement and Profit and Loss Statement in the Phi Gamma Nu Magazine on completion of the Fiscal Year.

ARTICLE XIV.

Section 1. amended to read as follows: Official Magazine. There shall be an official magazine published quarterly during the collegiate year under the supervision of the Grand Editor.

By-Laws

ARTICLE IV

Section 1. amended to read as follows: Incorporation of Chapters. A chapter shall be incorporated under a name, the form to be as follows: "-----Chapter of Phi Gamma Nu Sorority," except when permission is given by the Supreme Council to change the form.

ARTICLE V.

Section 7. amended to read as follows: Nomination of Grand Officers. Nomination shall be made by a nominating committee of five official delegates appointed by the Grand President at the first meeting of the Grand Chapter Congress; additional nominations may be made from the floor of the Grand Chapter Congress.

Denver Alumnae Chapter recommends changes in the
Constitution

ARTICLE IV.

Section 6. Omit - "Grand Extension Secretary" and "Grand Auditor". We feel that the extension work could be very satisfactorily handled by the five remaining national officers, each officer covering the territory in her vicinity. We suggest that a Certified Public Accountant be employed to audit the books yearly. Of course, these changes will have to appear in all sections where these officers are mentioned.

ARTICLE VI.

Section 2. We suggest the following additions to the duties of the Grand President: She shall have the power to sign contracts binding the Sorority. She shall appoint a Certified Public Accountant to audit the books.

Sections 5 and 7 would then be omitted under this Article.

We suggest the following additions to the duties of the Grand Treasurer: She shall supervise the installation and operation of a standard accounting system. She shall receive from the treasurer of each active and alumnae chapter upon her request a report of the

financial condition of the chapter. (We suggest that a financial report covering the past year be furnished on June 1).

ARTICLE VIII.

Section 2. Active and alumnae chapters shall hold their election on the same date. (For instance, at the first meeting in April).

ARTICLE X.

Section 1. We suggest the following change: Notice of petition must be filed with the Grand President.

Section 2 would have to read four-fifths, instead of five-sevenths vote.

In sections 3, 4, 6, and 8, where Grand Extension Secretary is mentioned, we suggest that the change to Grand President be made.

Theta Chapter recommends changes in the Constitution

ARTICLE IV.

Section 7. This section would seem to limit membership to those students who are actually taking the required subjects as well as the number of hours for majors in commerce. We would like to know if it includes those who have enough hours for a commerce major, but are taking their degree in education in order to become a commercial teacher.

ARTICLE V.

Section 3. Inasmuch as it has been impossible to enforce this regulation, it would seem no longer an essential part of the constitution.

Constitution

Article I. Sec. 1 Purposes instead of objects.
 Article III. Sec. 1 (having Eise Quam Vici translated in English following the Latin).
 Article VII. Sec. 4 line 11. Membership for one year.
 Article XI. Sec. 5 There is a question about this.
 Article XIV. Sec 1 Publications, the name of the Magazine.

By-Laws

Article V. Sec. 7 Nominations. Nominating committee appointed by the Grand Council instead of by the Grand President.
 Article IX. Sec. 4 The last line. The dues of active alumnae etc. Should be interpreted or in some other wording more specific as to the dues of the active alumnae members payable to the Grand Treasurer.
 Article XV. Sec. 1 Founcers Day. The order of the day should be incorporated in this section.

Suggestions of the Grand Secretary for Changes in the Constitution and By-Laws.

ARTICLE IV.

Section 6. Suggest that the Grand Extension Secretary and Grand Auditor be omitted or combined with other offices, and that the Grand Officers in their own particular district visit prospective chapters near their state.

ARTICLE V.

Section 1. Suggest that Grand Chapter Congress meet every three years and in the latter part of the summer, and as suggested by Grand President during her visit in Denver last summer, it might stimulate the chapters and be an inspiration just before the opening of the school term. Suggest that Supreme Council Members have a meeting between the time of the two conventions and believe this will help solve problems which come up during the half period which is so difficult to do by correspondence.

ARTICLE V.

Section 2. Elect only five National Officers instead of the seven as heretofore.

ARTICLE VI.

Section 1. Election and Tenure: Grand Officers hold office for three years instead of two.

Section 5. Eliminate Grand Extension Office.

Section 7. Eliminate Grand Auditor Office.

ARTICLE VIII.

Section 2. Time of Election: All chapters hold election at the same time, thus doing away with the inconvenience of having changes of officers come all during the year.
